Sessions Module B is 42 hours long and is spread out over a two-week period. Each day of the 7-hour course is delivered via videoconference from 9:00 a.m. to 4:30 p.m. with ATIP practitioners and a logistics support person in attendance

In addition to the lunch period, health breaks of 15-20 minutes are inserted during the morning and the afternoon.

Registration fees and teaching materials
